




# ANNOUNCEMENT OF AVAILABLE OIL BLOCKS

The National Oil, Gas and Biofuels Agency (ANPG), as the National Concessionaire, within the scope of the General Strategy for the Award of Petroleum Concessions for the period 2019-2025, approved by Presidential Decree no. 52/19, of February 18, informs that 23 opportunities are available for awarding, namely:

- 10 (ten) in the Onshore Basins of the Lower Congo and Kwanza (CON5, CON9, CON 10, KON5, KON17, KON 18, KON 20, KON 21, KON 22, KON 23),
- **7** (seven) in the Shallow Waters of the Kwanza, Benguela, and Namibe Basins (7/21, 8/21, 9/21,10, 11, 12, 13).
- 5 (five) related to the Limited Public Tender Process of the 2025 Licensing Round in the Offshore Kwanza and Benguela Basins (22, 25, 26, 38, 39), and
- 1 (one) Block with Marginal Discovery (free area of Block 18) (see attached for available opportunities).



Thus, in order to promote the exploration and production of oil and gas, and attract investors, ANPG will carry out a massive campaign in the main international markets. A set of companies with high technical and financial capacity will be invited to hold consultation meetings between April and September 2025, at a time and place to be agreed upon by the parties, with the aim of assessing the interest and expectations of potential investors, as well as presenting the geological and geophysical potential of the available opportunities, along with legal, contractual, and requirements for companies to associate with the National Concessionaire.
